

## **Rabies Neutralizing Antibody Titer Test Declaration (RNATTD) (for dogs/cats exported to Taiwan)**

<b>Section 1: General information</b>	
Purpose of this form	<p>For an Official Government Veterinarian employed by the animal quarantine authority of the exporting country to confirm that:</p> <ul style="list-style-type: none"><li>● the animal being exported to Taiwan has passed the rabies neutralizing antibody titer test (RNATT)</li></ul> <p><b>Passing the RNATT:</b> A dog/cat whose rabies neutralizing antibody titer level is at least 0.5 IU/ml in a blood sample tested by a World Organisation for Animal Health (WOAH) rabies reference laboratory or a laboratory designated by the Animal and Plant Health Inspection Agency (APHIA), Ministry of Agriculture (MOA).</p>
	<p>This form covers cats and dogs imported into Taiwan from (or via) a country (zone) not recognized as being free from rabies. And the declaration may be completed as part of the import permit application for dogs and cats being imported into Taiwan. If the application is completed as specified below, the animal may be exempted from none post entry quarantine (PEQ) period; if not, the animal will be held in quarantine facility for at least 7 days.</p>
	<p>This form cannot be completed by the same veterinarian who performed the RNATT preparations.</p>

The sending address is limited to the animal quarantine authority of the exporting country. One email is necessary per animal, the subject shall be the animal's microchip number, such as "123456789012345", and each email shall be less than 10 MB. 	<p>submission, it indicates that the submission was not successful.</p> <p>3. Please give the applicant the original or a copy of the RNATTD and a copy of the automatically generated reply confirming the submission.</p> <p><b>For applicants</b></p> <p>1. Please obtain and keep the original or copy of the RNATTD and the copy of the automatically generated reply confirming the submission. When you apply for the import quarantine permit, please submit them to the APHIA with other required documents (rabies vaccination certificate, RNATT report issued by the laboratory, and your ID, etc.)</p> <p>2. You may apply for waiving the post-entry quarantine when both of the following requirements are complied with</p> <p>(1) the animal having passed the RNATT with the blood sampled within 180 days to one year prior to importation; and,</p> <p>(2) the animal quarantine authority of the exporting country sending a photocopy of the RNATTD directly to APHIA (as above-described).</p> <p>3. If you do not plan to apply for waiving the post-entry quarantine or plan to apply for waiving the post-entry quarantine by complied with other regulations, the RNATTD is not required.</p> <p><b>For <u>rabiesreport@aphia.gov.tw</u></b></p> <p>It only accepts test reports sent by the laboratory or RNATTD sent by the animal quarantine agency of the exporting country, and only documents that comply with the mailing rules of preceding paragraph. Other documents will not be accepted, and no questions will be answered through this mailbox.</p> <p><b>Warning</b> : This form must be completed in full for the APHIA to consider it for assessment of an import quarantine permit. If the Official Government Veterinarian cannot complete the form, the permit conditions have not been met and the declaration should not be submitted.</p>
