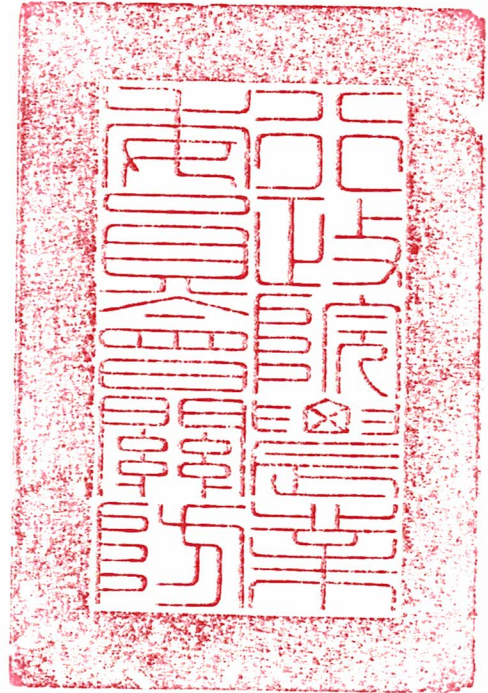

- 一、刪除CCC0603.90.90.00-3「其他花束用或裝飾用之切花及花蕾，乾、染色、漂白，塗裝或用其他方式處理者」等四十項品目。
- 二、修正CCC0604.90.11.00-8「其他水苔」等四十三項品目，於其備註欄新增免施檢疫之條件。
