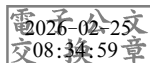

Add of prohibited hosts

The Animal and Plant Quarantine Agency (APQA), Ministry of Agriculture, Food and Rural Affairs (MAFRA) in the Republic of Korea, has added host plants of *Radopholus similis*, one of the prohibited quarantine pests of Korea, which is based on the result of Pest Risk Analysis (PRA).

The import of living and fresh underground parts of *Amydrum zippelianum* from the regions specified as below will be prohibited from the consignment with phytosanitary certificate, shipped on and after 18 April 2023.
