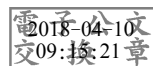

The following communication, received on 24 November 2017, is being circulated at the request of the Delegation of the Republic of Korea.

Import of living underground part of *Scindapsus* spp., *Epipremnum* spp. and *Monstera* spp.

Add of prohibited host

The Animal and Plant Quarantine Agency (APQA), Ministry for Agriculture, Food and Rural Affairs (MAFRA) in the Republic of Korea, has added host plants of *Radopholus similis*, one of the prohibited quarantine pest of the Republic of Korea, which is based on the result of Pest Risk Analysis (PRA).

The import of living underground part of *Scindapsus* spp., *Epipremnum* spp. and *Monstera* spp. from the regions specified as below will be prohibited from the consignment with phytosanitary certificate, shipped on and after 28 November 2017.

- Products covered: Living underground parts of *Scindapsus* spp., *Epipremnum* spp. and *Monstera* spp.
- Regions or countries likely to be affected, to the extent relevant or practicable:
 - North America: Canada, Mexico, United States
 - Central America: All countries
 - South America: All countries
 - Africa: All countries
 - Asia: Brunei, China (restricted areas: Guangdong-Guangzhou, Maoming and Shenzhen), India, Indonesia, Lebanon, Malaysia, Oman, Pakistan, Philippines, Singapore, Sri Lanka, Chinese Taipei, Thailand, Yemen
 - Europe: Belgium, France, Germany, Italy, Netherlands, Poland, Portugal, Slovenia
 - Oceania and the Pacific: Australia (except Tasmania), Fiji, Guam, Hawaiian Islands, Micronesia, Palau, Papua New Guinea, Polynesia, Solomon Islands
